State v Anderson	22CR61822	Defendant mother allowed 3 yr old child to live in home with rampant drug activity and child tested positive for meth
State v Williamson	23CR22187	Co-defendant parents used drugs in presence of 4 children in home, resulting in 5 yr old child testing positive for meth. This defendant is dad.
State v Pastor	23CR22192	Co-defendant parents used drugs in presence of 4 children in home, resulting in 5 yr old child testing positive for meth. This defendant is mom.
State v Neil	24CR21552	Defendant mom and other adult family members used drugs in home in presence of children, resulting in 3 yr old 5 yr old, and 7 yr old testing positive for meth
State v Wallen	23CR34946	Defendant mom overdosed (revived) along with her partner (died) in an apartment with 5 kids. Meth, marijuana, and fentanyl located in the home. Two kids (ages 3 and 10 yrs old) tested positive for meth.
State v Hathaway	23CR44609	Co-defendant parents used drugs in the garage of the family home, resulting in 3 yr old child testing positive for meth and cocaine. This defendant is mom. Dad resolved by guilty plea.
State v Casey	23CR53464	Co-defendant parents used drugs in presence of 3 children in the home, resulting in all three (ages 18 months, 2 months and 9 yr old ) testing positive for Norfentanyl, a fentanyl metabolite. This defendant is dad of 2 of the children. Mom resolved by guilty plea.
State v Cole Cooper	24CR44513	Defendant and roommates smoked marijuana in the home multiple times per day, resulting in 2 of the 4 children in the home ( ages 2 and 4 ) testing positive for THC.
State v Gentili	24CR46244	Co-defendant parents smoked marijuana in the presence of the 3 children in the home, while defendant was pregnant with her 4 <sup>th</sup> child. This resulted in two children testing positive for THC (ages 3 and 4) and infant testing positive at birth several days later. This defendant is mom.
State v Fulop	24CR46246	Co-defendant parents smoked marijuana in the presence of the 3 children in the home, while defendant mom was pregnant with her 4 <sup>th</sup> child. This resulted in two children testing positive for THC (ages 3 and 4) and infant testing positive at birth several days later. This defendant is dad.
State v Malet	24CR32739	Defendant father use drugs in presence of 3 yr old child, resulting in child testing positive for meth.

State v Roth	24CR30024	Defendant mother used drugs in presence of 6 yr old child, resulting in child testing positive for meth.
State v Ingrim	24CR38196	Defendant mother self-admitted fentanyl use to hospital workers while giving birth. At birth, infant tested positive for THC, fentanyl and methadone. 5 yr old sibling also tested positive for Norfentanyl, a fentanyl metabolite.
State v Buckhannon	25CR08400	Defendant father used drugs in the home, resulting in 7 yr old child testing positive for meth. Child described seeing Defendant smoke from a pipe and looking "crazy" after smoking.
State v Kilness	25CR27044	Defendant mom overdosed (revived) with autistic, non- verbal 5 yr old child present. 5 yr old then tested positive for meth.
State v Torres Garcia	24CR58855	*Case 1 of 2 for this defendant.* Defendant mother used drugs in presence of two children in the home, resulting in 3 yr old testing positive for meth.
State v Torres Garcia	25CR20625	*Case 2 of 2 for this defendant.* After the inception of 24CR58855, Defendant mother admitted using drugs at a group home she lived in with her children, resulting in 6 yr old testing positive for meth.

State v Morris	25CR27673	Co-defendant parents used drugs in the presence of their 4 children, resulting in 11 yr old child testing positive for meth and cocaine. This defendant is mom.
State v Spinney	24CR37357	Defendant mother arrested for retail theft with 4 yr old in the vehicle and meth in Defendant's possession. 4 yr old tested positive for meth and fentanyl the following day.
